Department of Statistics: Consumer Price Index (CPI) Increased by 2.12%in February 2025

The Department of Statistics issued its monthly report on the Consumer Price Index (Inflation) for February 2025 which recorded an increase by 2.12% compared to the same month in 2024, and a slight increase of 0.11% (less than one percentage point) compared to the previous month of January 2025. On a cumulative basis, the index for the first two months of 2025 increased by 2.21% compared to the same period in 2024.

Accordingly, the CPI for February 2025 has reached 112.36 against 110.02 for the same month in 2024, while the CPI for February 2025 has reached 112.36 against 112.23 for the previous month of January 2025. On a cumulative basis, the index for the first two months of 2025 stood at 112.30, compared to 109.87 for the same period in 2024.

In terms of commodity groups, the groups that mainly contributed to the increase of the CPI for February 2025 compared to the same month in 2024 are the "Personal Effects" by 18.39%, "Tobacco and Cigarettes" by 12.73%, "Meat and poultry" by 8.69%, "Spices, food additives and other food" by 5.34%, and "Culture and Entertainment" by 5.18%. Meanwhile, the increase was mitigated by "Furniture, rugs and bedding" with a contribution of (3.46%), "Clothing" by (2.50%), "Household Supplies" by (2.31%), and "Vegetables and Legumes Dry and Canned" by (2.13%).

Among the most prominent commodity groups that contributed to the increase in the CPI for February 2025 compared to January 2025 were the "Personal Effects" group with an increase of 2.87%, "Fish and Seafood" group by 1.02%, "Meat and Poultry" group with

by 0.97%, "Communications" group by 0.75%, and the "Beverages and Refreshments" group with an increase of 0.55%.

When comparing the cumulative CPI for the first two months of 2025 with the same period in 2024, the index for the "Personal Effects" group increased by 16.69%, "Tobacco and Cigarettes" group by 12.73%, "Meat and Poultry" group by 8.70%, "Spices, food additives and other food" by 5.32%, and "Culture and Entertainment" group by 5.07%.




Figure 1: Monthly CPI for 2024 and 2025
